

Cannabis Community Project Membership Agreement

This Membership Agreement (“Agreement”) is entered into between Cannabis Community Project, LLC and _____.

I. PURPOSE

The purpose of this Agreement is to provide membership benefits in Cannabis Community Project is to establish a common communication channel for members to share educational and entertaining ideas and discuss business issues relating to the Cannabis industry. We seek to enhance activism activities through our Radio Show. We seek to engage all listeners of the Cannabis Community Project, and to encourage cross-marketing for the products and services of its business members and collaboration in events and promotions. Through its system of membership fees, the Cannabis Community Project aims to cover its expenses for producing the Radio Show, hosting its website and other media activities.

II. DEFINITIONS

- A. “Agreement” means this Membership Agreement.
- B. “CCP” means the Cannabis Community Project, LLC.
- C. “CCP Store” means an on-line catalogue and advertisement pages for goods and services offered by the Business Members of CCP. The CCP Store provides an online payment service for items offered for sale in the catalogue.
- D. “Image” means a single picture or graphic 400 x 400 pixel in JPEG or PNG.
- E. “Listing” means one or more images displayed in the CCP Store for a single good or service, or for a collection of goods and services, offered by a Business Member. Listings may be used either to advertise goods and services provided by the Business Member, or to offer them for sale online.
- F. “Member” means a Person who enters into this Agreement with CCP.
- G. “Person” means a natural person, a partnership, a limited partnership, an unincorporated association, a corporation, or a limited liability company, or any other corporate form recognized under the laws of the State of Colorado.
- H. “Preferred Placement” means the first products displayed in CCP store.

I. “Radio Show” means the regularly scheduled broadcasts distributed via the CCP RSS feed. This agreement does not pertain to rebroadcasts outside the RSS feed or terrestrial airwave broadcasts. There are 48 shows uploaded a year to the RSS feed. There is one show a week, with exceptions for breaks and holidays. There are no scheduled dates for breaks and holidays, but they are taken at the discretion of the CCP producer. Each show is made public through the CCP RSS feed on Saturdays at 4:20pm MST. Some sites receiving the RSS feed may not update immediately, but the show is available directly from the CCP website and the RSS media host at speakr.com.

J. “Special Offers” means special promotional opportunity for goods or services extended exclusively to members. These offers come in messages delivered via text, email, social media, and / or on air announcements.

III. MEMBERSHIPS

CCP offers three Individual Memberships and one Business Memberships. Each membership has a different membership fee and provides a particular array of benefits.

3.1. Memberships Offered

3.1.1. Individual Memberships

Individual and business memberships are available to individual persons over the age of 21. Levels of Memberships are as follows:

- Individual Membership Level I: “Listener”;
- Individual Membership Level II: “Follower”; and
- Individual Membership Level III: “Fan”.

3.1.2 Business Membership Level I: “Feeling the CCP Waters”

3.2. Description of Costs and Membership Benefits

3.2.1. Individual Membership Level I: “Listener”

Fee: \$48 per year

Benefits include

- A one-time 10 percent discount on the purchase of any product or service offered in the CCP Store;

- 5 percent discount on purchases from the CCP Store for 90 days from the Anniversary Date;
- One CCP T-shirt;
- One free download from the music album “Rebellion” by Reason to Rebel, featuring the hit track “Open Up,” as heard at the beginning and end of every Radio Show;
- Exclusive access to the archives of prior CCP Radio Shows;
- Special Offers.

3.2.2. Individual Membership Level II: “Follower”

Fee: \$96 per year

Benefits include

- A one-time 15 percent discount on the purchase of any product or service offered in the CCP Store;
- 7.5 percent discount on purchases from the CCP Store for 180 days from the Anniversary Date;
- Choice of one CCP apparel item;
- One free download of any music album available from the CCP Store
- Exclusive access to the archives of prior CCP Radio Shows; and
- Special Offers.

3.2.3. Individual Membership Level III: “Fan”

Fee: \$192 per year

Benefits include

- A one-time 25 percent discount on the purchase of any product or service offered in the CCP Store;
- 12 percent discount on purchases from the CCP Store for one year from the Anniversary Date;

- Choice of two CCP apparel items;
- A virtual name plaque identifying Member as "Official CCP_Fan" in a dedicated space on the CCP_Website.
- One free download of any music album available from the CCP Store;
- Exclusive access to the archives of prior CCP Radio Shows; and
- Special Offers.

3.2.4. Business Membership Level I: "Feeling the CCP Waters"

Fee: \$300 per year + one-time \$25 set-up fee

If Member already has already purchased Individual Level III "Fan" membership, then they may combine that membership with business Membership Level I, for a total fee of \$371.88 per year + one-time \$25 set-up fee.

Benefits include

- One Listing in the CCP Store with up to 10 Images;
- Link to Member website.

IV. GENERAL TERMS AND CONDITIONS

4.1. Effective Date and Anniversary Date

This Agreement takes effect upon its execution in the signature blocks, below, by both CCP and Member. The Agreement may be signed in counterparts. The Anniversary Date is the first day of the month following the effective date.

4.2. Payment

Payment of annual fees and first payment of recurring monthly fees are due upon signing this Agreement. All other recurring monthly fees are due on the first day of each month. Payment shall be made to "Cannabis Community Project." CCP accepts Cash, Paypal, Credit Cards, Checks. Member agrees to pay any additional fees associated with payment processing.

4.3. Confidentiality

All information provided by Member for Listing is presumed to be public information and not confidential. CCP agrees not to list or otherwise disclose any other information that Member provides to CCP that Member informs CCP in writing should be treated as confidential.

4.4. Listing Format, Design and Content

Member shall be responsible for providing CCP with all materials to be included in a Listing, including both images and text. Images, including logos, must be provided in .jpg or .png format. Text shall be provided in Microsoft Word. Other formats may be accepted by CCP in its sole discretion. Member may reasonably cooperate with CCP in preparing a Listing, but CCP retains full discretion to make all final decisions with respect to format, design and content.

4.5. Ownership

Member may provide certain proprietary materials to CCP under this Agreement. Member hereby grants CCP a license to use such materials for use in Listings and other promotional activities relating to the business of CCP. All materials created by CCP for a Member are the exclusive property of CCP.

4.6. Term and Renewal

This Agreement shall have a term of one year from the Anniversary Date. The Agreement shall renew automatically thereafter for additional terms of one year, unless terminated. A sixty day notice of renewal will be sent via email.

4.7. Termination

4.7.1. This Agreement may not be terminated during the first year following the Anniversary Date, except for good cause. After the first Anniversary Date, this Agreement may be terminated by either CCP or Member at any time for any reason, with one month prior Notice.

4.7.2. The Termination Date is the last day of the month following the month in which Notice of Termination is given. For example, if Member provides Notice of Termination on May 19, then the Termination Date shall be June 30.

4.7.3. CCP will provide membership benefits through the Termination Date. Member remains responsible to pay Fees up through the month in which the Termination Date occurs.

4.8. Creative Control

CCP retains the right to exercise its own discretion over design, format, content and placement of Mentions, Radio Show programming, and the CCP website.

4.9. Notices

All notices, demands or statements of any kind between CCP and Member shall be given in writing. Notices may be hand-delivered or delivered by U.S. Mail, text messaging, facsimile or electronic mail to the following:

4.10. Governing Law and Construction

This Agreement shall be construed and interpreted in accordance with the laws of the State of Colorado. It shall not be construed against the party on whose behalf it was drafted solely because of the fact that that party drafted it.

4.11. Disputes

In any dispute arising under this Agreement that results in either an arbitration or litigation, the prevailing party shall be entitled to an award of their reasonable attorney fees and costs.

4.12. Waiver

Waiver by either party of enforcement of any term or condition of this Agreement in any particular instance shall not be construed as a continuing waiver or waiver of any other term or condition.

4.13. Assignability

This Agreement may not be assigned by either party without their written consent.

4.14. Integration

This Agreement contains the entire agreement between CCP and Member with regard to the matters set forth herein. It supersedes any and all prior agreements and understandings, whether written or oral, relating to the same subject matter. This Agreement may be amended only in writing and signed by both CCP and Member.

4.15. Severability

In the event that any one or more of the provisions of this Contract shall be found to be invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions contained herein shall not in any way be affected or impaired thereby.
